This seminar provides a look at a variety of case systems from a typological perspective (including various split ergative systems, Kasusaufnahme, and differential object marking) and aims to develop a theoretical understanding of them, in particular the role of case in voice alternations (passive, antipassive, and other valence-changing morphology). Special attention is paid to Austronesian, Australian, Native American, Indo-Aryan, European, Turkic, Eskimo, Basque, and Caucasian languages.
