**Course description:**

The first of a two-quarter survey of the major landmarks in the study of Buddhism in the modern academy. Beginning with the earliest studies and the landmark publication of Eugène Burnouf's *Introduction à l'Histoire du Buddhisme Indien* (1844), through the demise of Louis de la Vallée Poussin (1938), we will examine the progress of Buddhist Studies: institutionally, intellectually, and ideologically. Attention will be given to tracing the outlines of the historical contexts, strategies of legitimization, sources of funding and institutional foundations, and directions of research which characterize the study of Buddhism in its formative period.

**Prerequisites:** Reading knowledge of French; pref. some knowledge of Buddhism.
