This class is an introduction to the study of public opinion. We will examine such topics as the meaning of public opinion, forces affecting the formation of public opinion, the distribution of opinion on major issues, and the consequences of public opinion in modern politics.

The grading for this class will be based on two short papers (5-10 pages, 33% each), and a final (33%). The short papers should synthesize an argument from a single week's readings. The short papers should not be literature reviews, but criticisms of central themes in the readings. Appropriate short paper topics might examine the implications of the research approaches for the conclusions drawn by the different readings, point out central problems that the readings fail to address, extend the implications of one reading into the conclusions of another, and so forth. Brehm will provide a suggested list of these topics.
